14/15-84 Approval of Minutes

Minutes of the last meeting were approved as a true and accurate record.

14/15-85 Declarations of Interest

14/15-86 Matters arising from the Public Forum

(a) Concern was expressed about the strimming of grassed areas where poppies were growing, particularly in view of the centenary of the Great War of 1914/18 and it was-

<u>RESOLVED:</u> That the following areas would be designated as poppy protection areas – Triangle at Church Lane/High Street junction and at Low Road/Clay Bank.

- (b) Strimming on the riverbank adjacent to 25 Low Road and the objective of encouraging and maintaining wildflowers, wildlife and insects was discussed and it was suggested that the area be left uncut. It was pointed out that it was essential that the public footpath be maintained. Planting of trees in the area was discussed at 14/15 –90.
- (c) It was agreed that the Clerk would contact local farmers requesting donations of fuel for the village tidy group machinery.

14/15-87 Parish Council Election matters

Clerk outlined the post nomination position. There had been 2 nominations for election to 7 seats and the Returning Officer had declared that the 2 nominees, Eric Langley and Peter Goode, had been deemed as having been elected. As this left the Council inquorate the Ward District Councillor (yet to be elected) would be appointed a voting member. Immediately following the AGM, at which a chairman will be elected, a Council meeting will be in a position to consider applications from interested parties to be co-opted to vacant seats. Messrs Coy, Head and Midgley expressed an interest and on receipt of their written application (and those of any other interested parties) Clerk will submit names for consideration by Council at its first meeting on 21 May unless the Returning Officer calls a bye —election, in which case the foregoing may need to be reconsidered.

14/15-88 Transparency Regulations

Clerk outlined new regulations under the Localism Act:-

Any items of expenditure exceeding £100 must be published.

Asset Register must be published.

Clerk to liaise with webmaster of Village website to ensure that the Council is compliant.
