### **4/05/12 Feedback on action points**

- × **Land Registry**-clerk informed the meeting that she had investigated the adoption of the land. The process, which the clerk at first reported looked complicated was in fact more straightforward according to the Chairman. **Action:** Clerk to print off form needed.
- × **Dog Fouling letter**-clerk reported that the leaflet had been distributed.
- × **Grass cutting**-the clerk reported that she had not been able to obtain figures from LCC for the cost of grass cutting for other villages. **Action:** The Chairman asked the clerk to pursue this under the freedom of information act.
- × **Best Kept Village Competition:** The clerk reported that the entrance forms had been sent in.
- × PC Martin Derbyshire introduced himself and explained that he was part of the team of three looking after the area now that PC Daniels had moved on. Cllr M Head asked if the police had a regular routine or whether their response was based on a as and when basis. PC Derbyshire responded by saying that they had a huge area to cover and they were in the process of developing a strategy to cover. The biggest concern the village had was the issue of speeding through the village, particularly at shift change over time at Moy Park.

### **5/05/12 Financial Statement**

Cllr M Head reported that the balance of the account at the end of the financial year was £5,320.09. There were invoices of £50.00 and the clerk's salary of £650 to go through.

Cllr Head presented an invoice for £6.60 for the Dog Fouling leaflet. This was proposed by Cllr A Johnson and seconded by Cllr D Wood.

An invoice for fuel of £49.00 for the mowers was also presented. This was proposed by Cllr R Walley and seconded by Cllr S Coy.
