15/16-21 Approval of Minutes Minutes of the last meeting were approved as a true and accurate record and duly signed by the Chairman and Clerk.

15/16-23 Matters arising from the Public Forum.

- a) Sam Stainton, one of the two South Kyme Responders, along with Development Officer, Mr Chadwick outlined the essential work carried out by the organisation in responding to 999 calls prior to the Ambulance Service target of 8 minutes and noted that 5 Responders currently cover North and South Kyme, Anwick and Billinghay. The organisation was looking to raise funding in the region of £2000 to maintain the service.
- b) The dilapidated state of the signs for the Golf Club and a Flower trader at Skinners Lane End was noted and it was:

RICHARD LENNARD (LCC Area Highways Manager) Cllr PETER GOODE – Cllr MERVYN HEAD PETER AYRE (Clerk)

1 Mr Lennard has undertaken to:-Patch footpath at the end of the footbridge

Install a short length of kerbing outside 56 High Street

Reset or replace the rocking kerb outside The Hume

Patch a number of selected areas of Low Road (max 10m2)*

Has written to the occupants of 29 Low Road requesting re-instatement of the verge

Patch carriageway opposite 11 High Street

Works to be completed before March 2016

*This may need a road closure (access only) for which 3 months notice is required

2 A number of areas fall outside Mr Lennard's responsibility and he has referred the following: Stability checks have commenced on the High Street riverbank and "if felt necessary" additional piling or gabions will be installed (Likely to be a long term project)
