44/08/10 Feedback on action points

- **Lighting of the Church**-the clerk reported that no action can be taken by the Parish Council without the agreement of the Church via a faculty. Action: The Chairman asked the clerk to write to the secretary Mrs C Cass to ask that this be put in motion.
- **Footbridge**-clerk reported that engineers had looked at the footbridge and deemed it non urgent. It will be repaired within the next two months.
- **Invitation to Stephen Phillips QC MP**- the clerk reported that as yet no date agreed for him to attend a meeting of South Kyme PC as he is in fact on holiday until 26th August
- **Village broadband**-Chairman attended a meeting of Billingham Village Hall meeting and they are in agreement for the hall to be used for the siting of necessary equipment. The Chairman will invite Mr O'Rourke to attend the next meeting to explain in more detail. However, 46 more people need to sign up if cots are to be kept low. Cllr A Johnson will produce leaflets to publish the scheme.
